Acceptable forms of payment are cheque or wire transfer.

DCI will not disclose personal information about its clients or former clients to any person, except as agreed in the Terms of Business or as otherwise permitted by law.

Before you can purchase an Israel bond by completing this investment form you have to be an approved client of DCI. If you are not sure if you have already been approved, please consult your local representative.

Israel bonds can be denominated in Euros, British Pounds Sterling or United States Dollars. If the currency you remit is different from the currency of the bond, Computershare will convert your payment at an exchange rate determined by Computershare. The currency you remit, after conversion, must be more than or equal to the principal amount of the bond you are purchasing. Any excess will be refunded to you in the currency of the bond. All principal and interest payments will be made in the currency of the bond.

The Israel bonds available and their interest rates quoted in the applicable Final Terms on our website www.israelbondsintl.com are valid only for the specified issue date. We also encourage you to view our other details relating to the bonds which can be found on the Information Memorandum.
